6. INSURANCE

The promoter of an event forming part of the series must procure that all competitors, their personnel and drivers are covered by third party insurance. The policy must comply with the national laws in force as well with the hoisting ASN's requirements. Sight of the policy must be made available to the competitors on demand. Third party insurance arranged by the organiser shall be in addition and without prejudice to any personal insurance policy held by a competitor or any participant in the event concerned. Drivers taking part in a Challenge event are not third parties with respect to one another. Organizer guarantees an insurance of civil responsibility towards third parties

7. PROTESTS AND APPEALS

7.1 All protests will be lodged in accordance with the Code. All protests must be made in writing and handed to the clerk of the course or his assistant, or in their absence any of the stewards of the meeting, together with the sum of \in 500. If the protest requires the dismantling and re-assembly of different parts of a car, the claimant must make a deposit of \in 3.000.

9.1 FIRE EXTINGUISHERS

Each Driver is responsible for ensuring that a single piece extinguisher of minimum 5 kg is available within his own team area inside the paddock.

Each driver is requested to ensure that a plastic sheet (minimum dimensions 4 metres by 5) is spread on the ground in the place reserved for his team where work is to be done on his car, in order to prevent any pollution in case of an accidental leak, etc.

The Drivers' Liaison Officer will be recognisable by coloured vest. He will be reached at the Driver's Paddock during the race. Detailed time schedule will be published on the Official Notice Board.
