

SUPPLEMENTARY REGULATIONS



FOR COMPETITIONS OF 2020 NORTH EUROPEAN ZONE BALTIC RALLYCROSS CHAMPIONSHIP – ROUND 1 LATVIAN RALLYCROSS CHAMPIONSHIP AND CUP – ROUND 1 LITHUANIAN RALLYCROSS CHAMPIONSHIP – ROUND 1

4-5 JULY 2020, BIKERNIEKI, RĪGA, LATVIA.

The Competition is held under the FIA International Sporting Code (ISC) including Appendices and all competitors, drivers, organizers and officials, on behalf of themselves, their employees and agents, undertake to obey the Latvian Automobile Federation (LAF) National Sporting Code. The Competition shall be run in accordance with:

- The North European Zone (NEZ) Baltic Rallycross Championship (BRX) sporting regulations 2020 and NEZ BRX technical regulations 2020 for competitors and drivers who participate in NEZ BRX and Lithuanian rallycross championship (LTRX).
- The Latvian rallycross championship and cup (LRX) sporting regulations 2020 and LRX technical regulations 2020 for competitors and drivers who participate in LRX (only for those starts with will be organized separately from BRX).
- These Supplementary regulations.

REGULATIONS

In case of disputes about things not covered by the Code, the BRX sporting regulations and their related documentation, they will be solved in accordance with the FIA documentation (Article 3.16. of the ISC) of the particular racing discipline.

The final text of the BRX sporting regulations and the related documentation shall be the English version, which will be used should any dispute arise as to their interpretation.

Headings in this document are for ease of reference only and do not form part of these Supplementary Regulations.

RESPONSIBILITY

Anyone who participates in the race do so under their responsibility and at their own risk. FIA, Latvian Automobile Federation (LAF), organizer and officials cannot without fault be liable for personal injury or property damage during the competition.



III. GENERAL CONDITIONS

a) This Competition will count for:

North European Zone Baltic Rallycross Championship 2020
 (NEZ Super 1600, NEZ Touring car, NEZ Super 2000, NEZ OPEN, NEZ 4WD)

- Latvian rallycross championship and cup 2020

(Championship: Super 1600, Touring car, Open RX, LADA RX, Xtreme) (Cup: BMW RX 3000, CK 650, Junior 1000)

- Lithuanian rallycross championship

(Super 1600, Touring car, Super Car, 2000 Super, Junior 1000)

National Cup – support race.

(Crosskart: CK 85, CK125, Crosskart Xtreme Junior, Crosskart 250 / 650 / 650 Seniors, in accordance with the NEZ Crosskart Championship technical regulations 2020)

c) Participants:

- BRX is open to drivers/competitors with the national license issued by FIA North European Zone
 members ASN or International licences appropriate for Off-road competitions. EU Professional
 Competitors or Drivers shall be entitled to take part and score points in Zone Competitions taking
 place in European Union or comparable countries on the same basis as national licence-holders of
 those countries.
- **LRX** is open Championship to drivers/competitors with the A, B (RX) level licenses issued bay Latvian ASN Off-Road Commission or licenses for Off-Road competitions issued bay their ASN or International Off-Road licenses.

Foreign drivers/competitors who wish to take part in an LRX can only do so with the prior approval of their Parent ASN (this authorisation shall be given by the ASN concerned in such form as they might deem convenient) and if they have paid:

- 135 EUR per season, payment must be made before first LRX competition.
- or 50 EUR per competition, payment must be made before the competition.

Payment must be made with a transfer to LAF (Swedbank account No. LV55HABA000140J032785, swift code: HABALV22).

- LTRX is open to drivers/competitors with the licenses issued bay Lithuanian ASN or International Off-Road licenses.
- **Support race** is open to drivers/competitors with the national license issued by their ASN or International licences appropriate for Off-road competitions.

All drivers with a national license from NEZ countries are responsible to have insurance in the license or separate, they must have a valid license issued by their ASN country.

d) Registration / entries:

- Registration must be provided to RAC.LV no later than Monday, June 29th, 2020.

e) Registration / entry fee:

- Entry fee 200 Euro for NEZ BRX (all BRX categories, including LRX Open RX and LTRX all those categories who will start under the BRX categories);
- Entry fee 130 EUR for LRX (Super 1600, Touring car);
- Entry fee 100 EUR for LRX (LADA RX, BMW RX, Xtreme, CK 650);
- Entry fee 50 EUR for LRX and LTRX (Junior 1000);
- Entry fee 200 EUR for BRX Support race (Xtreme);
- Entry fee 100 EUR for LRX (04.07.) Support race (Crosskart: CK 85, CK125, Crosskart Xtreme Junior);
- Entry fee 100 EUR for BRX (05.07.) Support race (Crosskart: CK 85, CK125, Crosskart Xtreme Junior);
 Crosskart 250 / 650 / 650 Seniors);









- Late registration fee (later than Monday, June 29th) + extra 50 Euro
- Entry fees can be paid by bank transfer to the event organizer Biedrība RAC.LV
 SEB Bank account (account no. IBAN LV05UNLA0055001537556, SWIFT/BIC: UNLALV2X).
 The payment must be made before the BRX event where the driver plans to first compete. Entry Fee can be paid in CASH at race secretariat.

As the entry is made the Driver and the confirmation of the acceptance from the organiser is considered as a contract, the Driver, not coming to the Competition, must apologise giving the reason as soon as possible. Notify must be sent by email to info@rallycross.lv.

f) Entry fees may be refunded only:

- to candidates who are not accepted.
- in the case of the Competition not taking place.
- if the Competitor withdraws his entry no later than the Monday before the Competition. If the withdrawal is announced to the organiser between that Monday and the opening of the administrative checking, 50% only of the entry fee will be refunded.

g) Running of the event:

- Free Practice 3 laps (one-time)

Qualifying heats 4 lapsSemi-finals and finals 6 laps

IV. PROTESTS AND APPEALS

The protest fee is 300 EUR

- The appeal fee set by the ASN is 1000 EUR

All protests will be lodged in accordance with the Code. All protests must be made in writing and handed to the Clerk of the Course or his assistant, or in their absence any of the Stewards of the Competition, together with the required protest fee.

V. NOISE CHECKING

For all cars, a limit of 100 dB is imposed.

VI. PARC FERME

- Only those cars having taken part in the Finals (not in the Semi-Finals) must be brought by the Drivers to the Parc Fermé immediately after the finish, except for cars not having completed the race for reasons other than problems with the engine.
- The cars shall remain in Parc Fermé for at least 30 minutes after the publication of the provisional results and until released by decision of the steward. In this area, it is forbidden to make any repair to the car or to carry out refuelling.
- Those Drivers who participate in support race or have been shown a black flag must return to the paddock and not the Parc Fermé.

VII. PODIUM. PRIZES AND CUPS

- According to NEZ BRX regulations for 2020.
- The podium ceremony on the circuit will be held immediately after the final results are published on the Official notice board. The Top 3 finishers must be present, wearing their Competition overalls. Failure to attend this ceremony and/or the wearing of inappropriate clothing will be penalised by a fine inflicted by the stewards.
- Per Competition, at least a cup will be awarded to the Top 3 Drivers, their country flag will be displayed and the winner's national anthem will be played (the nationality of the Driver being that of the ASN which delivered his Licence - Article 9.4.1 of the ISC).









VIII. INSURANCE

The organiser guarantees for all competitors of NEZ BRX, LRX, LTRX and Support race event the civil responsibility insurance. Details relating to the insurance will be specified later.

IX. OTHER INFORMATION

a) Electricity in the paddock is available.

b) Miscellaneous:

- Each participant may bring 3 mechanics/helpers free of charge. Others pay full entrance.
- Bicycles and electric mopeds are allowed with max speed 10km/h
- Any other motorized vehicles in the race territory/paddock area is forbidden.
- Max area of the paddock per participant 78 square meters (e.g. 13m x 6m)
- At arrival, please wait for the chief paddock to refer parking space in paddock.

c) Protection of the environment:

- In accordance with the NEZ Baltic Rallycross Championship 2020 regulations. Waste is to be left by the trash cans in the paddock. Everything brought to the race must be taken home again. Liquid collector and tarpaulin must be under the participant's vehicles while in the paddock.
- Each driver is requested to ensure that a plastic sheet (minimum dimensions 4 metres by 5) is spread on the ground in the place reserved for his team where work is to be done on his car, in order to prevent any pollution in case of an accidental leak, etc.
- Each team should have at least one 6kg fire extinguisher at their paddock place.
