INVITATION TO TENDER FOR SOLE SUPPLY CONTRACT

Lithuanian automobile sport federation's (LASF) objective is to select an exclusive supplier of tyres whose task will be to ensure the delivery of the tyres for 2022, 2023 seasons of Lithuanian automobile rally championship (LARČ).

Interested parties are hereby invited to tender to become the exclusive supplier of the tyres for the 2022, 2023 seasons of LARČ.

The selected tenderer will be invited to enter into a contract with the LASF that will establish the terms of the tenderer's appointment as exclusive supplier. The exclusive supplier will supply the products directly to the Competitors (not to the LASF) under terms and conditions to be agreed.

LASF reserves the right to make amendments to this invitation to tender at any time. Bids must be sent to the FIA Administration by e-mail to the following address: lasf@lasf.lt.

2. The description of merchandise:

2.1. Rally gravel tyres for cars:

- 2.1.1. Predictable amount of tires: ~ 650 units, LASF does not guarantee the SUPPLIER a minimum quantity of the PRODUCT to be supplied.
- 2.1.2. Year of production: 2020-2021 year;
- 2.1.3. Tyre dimensions: 175/70R15, 185/70R15 (provider can submit both) and 195/70R15 (provider can also these dimensions 205/65R15); the supplier have a possibility to provide the tires with different kind of marking system, that corresponds to the dimensions provided.
- 2.1.4. FIA barcode must be placed on both sides of the tire or on the external side.
- 2.1.5. Terms of delivery: at the time when the service park is opened in event location and 1 (one) month prior the competition in supplier's' warehouse.
- 2.1.6. The mounting and demounting service during the event;
- 2.1.7. Tyre inspection and control of usage during the event;
- 2.1.8. Possibility to purchase tires before the event in advance and during the event.
- 2.1.9. The price indicated in the offer must be guaranteed for three years in a row in case of agreement being renewed.

2.2. LARC calendar consist of 5-6 events each year. The predicted dates of 2022 events to be served at:

"Rally Žemaitija" June 2022
"Rally Viekšniai" July 2022
"Samsonas Rally Rokiškis" August 2022
"Rally Elektrėnai" September 2022
"Rally Aukštaitija" October 2022

This calendar is for acquaintance purposes only. Calendar is still not fixed, these dates can change according to agreement between LASF and The Organisers. Nevertheless, LASF commits to inform supplier about any changes in the calendar.

3. Price and terms of payment for merchandise provided.

- 3.1. The price of the product must include all taxes and suppliers' expenses (storage, transportation, packing, human resources, equipment expenses, mounting, checking and etc.).
- 3.2. The price of the product must be presented in Euro currency only. VAT must be indicated separately.
- 3.3. Terms of payment. Each LARC participant should pay for the tyres to the Supplier directly according to the fact.

4. Terms of offer submission and other requirements for offers.

- 4.1. All offers must be presented in written form in Lithuanian or English languages.
- 4.2. The offer must include:
 - 4.2.1. Title of the product
 - 4.2.2. Price of the product
 - 4.2.3. Validity date
 - 4.2.4. Type of compound
 - 4.2.5. Tread pattern (designation and diagram)
 - 4.2.6. Tyre size
- 4.3. The offer must be confirmed by the director of the company or by legally authorized individual (providing the letter of authorization) with signature and company's stamp;
- 4.4. The offer must include supplier company details (address, company registration code, VAT payers' code, contact phone number, contact fax number, directors' / CEO name and surname); the domicile and constant address of merchandise warehouse place;
- 4.5. The offer must include the copy of merchandise supplier company registration certificate as well as the note confirming that the company has a right to legally perform the activity indicated and has no direct connections and has no property or subordination relations with the legal entity in control of the supply (the note must be confirmed by the director of the company or authorized individual).

5. The submission of the Offer.

5.1. Bids and all relevant documents must be sent to the FIA Administration by e-mail to the following address: lasf@lasf.lt by 17-11-2021 13:00 h. The offers presented later than the date (term) indicated are not going to be accepted or taken into consideration.

6. Evaluation of Offers.

6.1. The legal entity in control of merchandise supply is going to evaluate and compare only those offers that correspond to the qualifications of the purchase documents as well as correspond to technical and economical requirements and were not refused or eliminated.

- 6.2. The valuation criteria of the offers used by the legal entity in control of product supply corresponds to the proportion of the price, the service (tyres control), quality of the merchandise and commercial support.
- 7. The supplier of tyres must cover all the expenses of the offer preparation and submission by himself. The legal entity in control of the supply is not responsible for these expenses.

8. The participation of subcontractors in the contest.

- 8.1. The tyre supplier has a possibility to invoke on capability of other industrial party in order to correspond to financial, economic and technical and (or) professional capability requirements. Thelegal nature of the relations is not considered.
- 8.2. If the supplier invokes the capabilities of the other industrial party, the supplier must prove to the legal entity in control of merchandise supply, that the resources of the third industrial party are going to be accessible to the supplier during the implementation period of the agreement. In order to substantiate that, the supplier must present the duplicates of purchasing agreements or other legal documents proving that the resources of the third party are going to be accessible to the supplier during the full period of agreement implementation. If the subcontractor does not meet the requirements applied to the subcontractor it could be replaced by the other third party over the period indicated by the legal entity in control of merchandise supply.
- 8.3. The supplier takes full and direct responsibility for its' subcontractors during the period of agreements implementation.

9. The information for participants about the results of purchase procedure and agreement composition.

- 9.1. After making a decision about the winning offer the legal entity in control of merchandise supply will immediately inform all participants about the decision. The supplier will be invited to make an agreement in writing, this will include the notification about the winning offer and details where and when the agreement will be made.
- 9.2. If the supplier, who was invited to make an agreement, refuses to do so, the next supplier in the winning line will be invited to make an agreement.
